Post Light(s)

Delaware County Code Compliance now enforces the 2019 Residential Code of Ohio. With the adoption of the 2019 Residential Building Code there have been changes in what types of construction require approvals and what is exempt from approvals. Please see section 105 of the 2019 Residential Code of Ohio provided below as you prepare to do work on residential properties.

Please be advised that replacement of any electrical, gas, mechanical, plumbing system, other residential building service equipment, or piping system, the installation of which is regulated by this code, or to cause any such work to be done, shall first make application to the building official and obtain the required approval. This includes furnace and hot water tank replacement.

<u>Code</u> **2019 Residential Code of Ohio**

SECTION 105 – **APPROVALS - 105.1 Required.** Any owner or authorized agent who intends to construct, enlarge, alter, repair, move or change the occupancy of a *residential* building or structure, *or portion thereof, or* to erect, install, enlarge, alter, repair, remove, convert or replace any electrical, gas, mechanical, plumbing system, *other residential building service equipment, or piping system, the installation* of which is regulated by this code, or to cause any such work to be done, shall first make application to the building official and obtain the required *approval*.

<u>Possible Permit (s)</u> Electric Permit

Electrical – fee type: Electrical alteration - \$75 + 1% State of Ohio fee; this fee covers one trip; a partial inspection fee * will be applied if multiple trips are involved (this does not include reinspections). The \$75 + 1% fee does not include other electrical installations being performed in conjunction with the post light(s) (i.e. sub panel, lighting, receptacles, etc) if additional electrical installations are proposed, such installations shall be indicated on the application and fees will be assessed accordingly.

Gas – fee type: Gas Piping alteration - \$50 + \$10/appliance + 1% State of Ohio fee; this fee covers one trip; a partial inspection fee * will be applied if multiple trips are involved (this does not include reinspections).

* Partial inspection fee: \$75.00 + 1% State of Ohio fee.
