APPLICATION FOR EQUIPMENT CHANGE-OUT

Delaware County Code Compliance enforces the 2019 Residential Code of Ohio. Please see section 105 of the 2019 Residential Code of Ohio provided below as you prepare to do work on residential properties.

Please be advised that replacement of any electrical, gas, mechanical, plumbing system, other residential building service equipment, or piping system, the installation of which is regulated by this code, or to cause any such work to be done, shall first make application to the building official and obtain the required approval. This includes furnace and hot water tank replacement.

Code **2019 Residential Code of Ohio**

SECTION 105 – APPROVALS - 105.1 Required. Any owner or authorized agent who intends to construct, enlarge, alter, repair, move or change the occupancy of a residential building or structure, or portion thereof, or to erect, install, enlarge, alter, repair, remove, convert or replace any electrical, gas, mechanical, plumbing system, other residential building service equipment, or piping system, the installation of which is regulated by this code, or to cause any such work to be done, shall first make application to the building official and obtain the required approval.

Fees

All applications will have a \$25.00 application fee and a 1% State of Ohio Assessment fee.

Furnace + A/C Unit: \$25 (Application Fee) + \$75 (Furnace Fee) + \$75 (A/C Unit Fee) + 1% State of Ohio Fee \$176.75.

Furnace + Heat Pump: \$25 (Application Fee) + \$75 (Furnace Fee) + \$75 (Heat Pump Fee) + 1% State of Ohio Fee \$176.75.

Gas or Electric Hot Water Tank: \$25 (Application Fee) + \$75 (Water Tank Fee) + 1% State of Ohio Fee \$101.00

***The cost per unit is \$75.00 regardless of the type of unit being replaced.**

These fees cover the necessary first time inspections. A partial inspection fee of \$75 will be applied if additional trips are involved (this does not include re-inspections). If new electric or gas service is necessary for the replacement, an additional fee of \$75 + 1% State of Ohio fee will be applied. The installation of an electric sub panel will also result in an additional fee of \$75 + 1% State of Ohio fee.
